THE COVID-19 PANDEMIC AND PRECAUTIONS TAKEN TO PROTECT ARF'S STAFF AND OUR COMMUNITY LED ARF TO LIMIT PUBLIC ACCESS TO THE SHELTER TO ADOPTIONS ONLY. ADDITIONALLY, RENOVATIONS AND NEW CONSTRUCTION AT ARF'S CAMPUS LED ARF TO MOVE PUBLIC ADOPTIONS TO ITS MOBILE VAN, LOCATED AT THE ARF THRIFT SHOP IN SAGAPONACK. SHELTER CAPACITY DURING CONSTRUCTION HAS BEEN REDUCED MORE THAN 50% DURING CONSTRUCTION. EVEN SO, A TOTAL OF 309 CATS AND DOGS WERE ADOPTED IN 2021, AND ARF RESCUED 347 CATS AND DOGS LOCALLY AND THROUGH OUR PARTNERS. IN 2021, ARF CONTINUED TO FOCUS SPECIAL ATTENTION ON REDUCING THE OVERALL LENGTH-OF-STAY OF ANIMALS IN THE SHELTER WITH INCREASED STAFFING AND PROFESSIONAL DEVELOPMENT TO ENSURE DOGS AND CATS RECEIVE ENRICHMENT, SOCIALIZATION, AND TRAINING TO REDUCE STRESS OF SHELTER-LIFE AND PROMOTE BEHAVIOR THAT WILL LEAD TO SUCCESSFUL

THIS VOLUNTEER-BASED PROGRAM IS MANAGED BY ARF STAFF WITH SUPPORT FROM ARF'S MEDICAL TEAM FOR TNR AND ANIMAL CARE STAFF TO ASSIST WITH TRAPPING. ARF PERFORMED 181 FREE SPAY/NEUTER SURGERIES FOR FERAL CATS IN 2021.
