NOW IN ITS 27TH YEAR, OP CAT HAS ALTERED OVER 33,500 CATS ACROSS EASTERN LONG ISLAND, HELPING CONTROL THE OUTDOOR CAT POPULATION AND REDUCE THE NUMBER OF KITTENS ENTERING THE SHELTERING SYSTEM.
